What we collect...

We may collect the following information:

- Your name, and that of your child or young person.
- Your address, and that of your child or young person (if different).
- Contact information for you, including your mobile phone number and email address.
- The name and telephone number of an emergency contact for you, your child or young person.
- Demographic information about you, your child or young person. This may include date of birth, gender and any additional or medical needs which may impact on the support or comfort during sessions.
- Information regarding the reasons for seeking support, details of support previously received and background information deemed to be relevant to the support.
- Pre and post-intervention measures, which may include completion of the PSYCHLOPS questionnaire and an Emotional Needs Audit.

What we use your information for:

• To communicate with you

- To inform the support delivered to you, your child or young person.
- Internal record keeping.
- To monitor, evaluate and improve our support.

Please get in touch if you do not wish your data to be retained. All electronic records will be deleted and paper documents securely destroyed. Your data will be retained for 7 years from date of receipt, unless you have asked for it to be deleted before then.
